Our Services

24/7 Crisis Hotline and Text Line

Blue Water Safe Horizons offers 24/7 access to trained crisis advocates through a dedicated phone line and text line. Whether someone is seeking shelter, would like a referral for crisis intervention or advocacy, or simply needs someone safe and confidential to talk to, our advocates are there to answer the call or text around the clock.

BWSH Emergency Shelter Program

BWSH Emergency Shelter Program provides temporary, emergency housing for survivors of domestic violence as well as their dependent children, and also to victims of elder abuse and exploitation. Survivors are housed off-site in private, confidential suites and each have their own advocate to work with for the duration of their stay. All services are free of charge, including their stay, crisis intervention and advocacy, legal advocacy, support groups, and enriching scheduled activities. We are working on getting them back on site currently.

Outreach Services

The Outreach Department provides numerous services to survivors of domestic violence and elder abuse. Supportive services provide survivors with specialized, trauma-informed crisis intervention and coping strategies, as well as support groups. Legal advocacy provides guidance and accompaniment to assist survivors in navigating the legal system, writing victim statements, and filing for protection orders. The Elder Advocate is well-versed in elder abuse and exploitation and provides support and assistance for obtaining resources that are helpful at overcoming unique situations. All of our advocates are there to support and encourage the survivor every step of the way on his or her journey of healing.

Program Impact

24/7 Crisis Hotline / Text Line

- Advocates assisted 154 **individuals** who called or texted our crisis line in 2024/2025. Equaling 1878 hours of service.

Emergency Shelter Program

- Provided 42 heads of households and their children with 1529 services with an average of 76 nights per client (this includes elder and SA)

Outreach Services

- 81 heads of households participated in Outreach services equaling 690 hours of service with 779 services.

Support Groups

- 19 individuals participated in Support Groups equaling 65.5 hours of service.

These numbers only reflect what can be extracted from our reporting system. It does not calculate the number of hours spent decorating, planning birthday parties, holiday parties, collecting gifts, making cakes, tiding the building so it is comfortable and calming for the survivors, hours of phone calls to secure housing, food resources, utility resources and new resources, meetings, awareness events, fundraising events, putting away donations or the time to rest and rejuvenate for the next survivor.
